Application for relaxing of the TTRLine 2 horse rule.

As a benefit of your EA membership ETas may be able to assist with the transport of your horses to the mainland for non-commercial use. If you are travelling to an Amateur event/function and will be returning to Tasmania with the same horses you may be entitled to the relaxation of the TTRLine 2 horse rule.

NB: the current TTRLine policy allows non-commercial vehicles travelling with 1- 2 horses to be booked as Accompanied vehicles. Vehicles travelling with 3 plus horses are required to pay full freighting rates. This rule may be relaxed if we can prove the horses will not be used for commercial use while away. I.e) Racing, Breeding, Horse sales etc
