



It is up to competitors to be familiar with the current EA Rules for Dressage. They can be accessed on the EA website www.equestrian.org.au

A friendly reminder for riders regarding the following points:

When presenting for your test, once you have entered the "Competition Area" (the light green shaded areas on page 2), horses may not be lead by another horse (or person). This is considered unauthorised outside assistance and will entail elimination for BOTH horses involved. Refer to rules 3.11, 3.12(e), 11.1. Note: The above does not apply during advertised Arena Familiarization times.

Bridle Numbers – Must be worn on BOTH sides of either bridle or saddle blanket in both warm-up and competition.

Arena Familiarization – Horses may be led or ridden (walk or trot only) around the arenas until 8:45am. The areas around the arenas are considered the 'Competition Area' and riders are only to ride there when ready to present to the Judge before their test, apart from the stated time for Arena Familiarization.

Gear Checking – MUST be completed BEFORE your test as per current EA rules. **Gear checking after your test** will result in elimination.

Lunging – For obvious safety reasons all lunging must be in the designated enclosed areas (preferably the round yard) or otherwise the fenced Pony Club area. Non-compliance will entail elimination. Refer rule 3.12.1. **This is a safety issue and must be respected by all.**

Yards – Please leave the yards clean if you use them.

Dogs – <u>NO</u> dogs allowed at TEC.

Children – Children under 10 are to be under adult supervision at all times for their safety and as a courtesy to competitors. Horses are unpredictable and DT accepts no responsibility for any accident or injury.



ATHLETE ANTI-DOPING INFORMATION

The Australian Sports Anti-Doping Authority (ASADA) is Australia's driving force for pure performance in sport and aims to protect Australia's sporting integrity through the elimination of doping. ASADA deters the use of banned doping practices in sport through education, testing, advocacy and coordination of Australia's anti-doping program. It is the organisation with prime responsibility for implementation of the World Anti-Doping Code in Australia.

Athletes are advised to check the status of their existing and new medications every year due to possible changes in conditions of use.

The WADA strict liability principle states the athlete is responsible for any substances detected, regardless of how they got there.
