1.0 Conditions of Entry

The Equestrian Tasmania (ETas) State Dressage Championships, and Dressage Tasmania (DTas) Participant Championships will be run in strict accordance with:

- 1.1. 2023 EA National Dressage Rules (www.equestrian.org.au/dressage-rules), EA General Regulations and all other EA policies and bylaws (www.equestrian.org.au/policies); FEI Statutes and General Regulations; FEI Veterinary Regulations; FEI Dressage Rules.
- **1.2.** Competitors are advised to be aware of the current rules and regulations. The onus is on riders to know the rules under which they compete.
- **1.3.** Current rules are dated 1/7/2023, but PLEASE NOTE THAT RULE **UPDATES** COME INTO EFFECT 1/1/2024.
- **1.4.** The EA Dressage Rules and Dressage Tests may be downloaded from the EA website https://www.equestrian.org.au/Dressage-rules.
- **1.5.** The FEI Dressage Rules and Tests can be downloaded from the FEI website: www.fei.org.
- 1.6. All EA and ETas events are subject to the EA Code of Conduct which can be accessed on the EA website via the following link:

 www.equestrian.org.au/sites/default/files/Equestrian_Australia_Code_of_Conduct.pdf.
- 1.7. It is important that all members and competitors understand that the Code of Conduct also covers parents, guardians and spectators in respect of any activity held or sanctioned by ETas. A key aim of the Code of Conduct is to respect the rights of everyone involved, to abide by all EA rules and requirements to be fair, considerate, honest and professional in all aspects of the sport.
- **1.8.** EA and DTas are committed to the protection and welfare of horses and its members.
- 1.9. The EA Member Protection Policy (MPP) can be accessed on its website at https://www.equestrian.org.au/sites/default/files/NIF%20Member%20Protection%20Policy %20December%202021.pdf
- **1.10.** The EA Social Media Policy, which should be read in conjunction with the MPP can be found at https://www.equestrian.org.au/sites/default/files/Equestrian_Australia_Social_Media_Policy_June%202023.pdf

These are important documents, designed to ensure the safe and fair conduct of the event for everyone involved. They should be read, understood and complied with.

2.0 Release and Indemnity

Riders and/or owners whose entries have been accepted will undertake to indemnify EA, ETas, DTas, Tasmanian Equestrian Centre, their servants and agents and the Organising Committee (OC) and each member thereof against all claims, losses, suits and damage made against or suffered by or on behalf of any participant or competitor named in their entry form for any loss or damage howsoever arising from any accident or incident occurring at the event.

Neither the aforementioned OC of any competition to which the EA rules for Dressage apply, nor the EA, accepts any responsibility or liability for any accident, damage, injury, loss or illness to horses, owners, riders, grounds, spectators or any other person, animals or property resulting from the conduct of the event whatsoever.

3.0 Insurance

All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.

4.0 Eligibility

- 4.1. Competitor (Official) horse and rider (combination) are required to receive two scores of 60% or more, at the level they have entered for the 2024 State Championships, between the qualifying period of 30 January 2023 to 22 January 2024. Please note qualifiers are not required for Para Equestrian, or Young Horse classes.
- **4.2.** FEI horse/pony and rider (combination) are required to receive two scores of 55% or more at the level they have entered for the 2024 State Championships, between the qualifying period of 30 January 2023 and 22 January 2024. Please note qualifiers are not required for Para Equestrian, or Young Horse classes.
- **4.3.** Participant (Unofficial) horse and rider (combination) are required to compete at two DTas Events between the qualifying period of 30 January 2023 to 22 January 2024.
- **4.4.** Horses/ponies may only compete at their graded level or higher, where eligible.
- **4.5.** Entries and the Competition Program may be limited and revised at the discretion of the Organising Committee (OC).
- **4.6.** The OC reserves the right to cancel classes if insufficient entries are received.
- 4.7. Pony Dressage (Competitor/Official classes only) will be run in accordance with current EA Pony Dressage rules. Please take care to select the corresponding class. Participant (Unofficial) classes do not include pony classes.
- **4.8.** With regard to heights, as per EA Rule 4.8.3.3 Heights of Horses & Ponies:
 - a) horses must exceed 149 cm with shoes or 148 cm without shoes
 - b) ponies entered for Competitive pony competition must comply with the regulations for horses in Rule 4.8.1 with the following exceptions and additions:
 - ponies must not exceed 149 cm with shoes or 148 cm without shoes
 - Ponies must have a valid height certificate.

5.0 Membership and Horse/Pony Registration

- 5.1. Ponies/horses entered in the Equestrian Tasmania State Dressage Championships (Competitor/Official section) must have a current EA competition licence for Dressage or Pony Dressage. Further; horses, owners and riders in Competitor/Official classes must be registered, and riders must be financial members of EA (Tasmanian or relevant State Branch) at time of entry. EA membership/registration numbers must be submitted with the entry.
- **5.2.** Horses must compete under their full registered name. The Organising Committee has the right to abbreviate a horse's name for printing purposes.
- **5.3.** Horses must be at least 3 years old to compete in EA classes, at least 6 years old for FEI Classes and 8 years old for Grand Prix and Grand Prix Freestyle.
- **5.4.** Riders competing in Dressage Tasmania Participant Championships (Preliminary and Novice classes) must be either a current member of Dressage Tasmania or Equestrian Australia.

6.0 Competition Licences for Official competitors

- **6.1.** Riders/owners should have their horses' EA Registrations available at the event.
- **6.2.** Performances will be cross-checked with the National EA results database; therefore, Performance Cards are not required to accompany entries. In the event of a discrepancy, competitors must be able to provide an up-to-date Performance Card if requested by the OC.

7.0 Horse Identification Numbers

- **7.1.** As per EA National Dressage Rules 2023, Rule 4.8.5: Horse Identification numbers are important for identification purposes and should be used at all times at an event.
- 7.2. Two Horse or Pony Identification numbers (as per listed competition number in program/draw), and stallion discs for stallions, must be worn on both sides (one per side) of the horse (preferably attached to each side of the saddlecloth, or each side of the bridle/headcollar), and must be clearly readable by the judges, being a minimum of 3.5 4 cm in height. The Horse or Pony Identification Number must also be worn as described whenever the horse is being ridden/lunged/led/tethered or grazed from the time of their arrival on the grounds until the end of the event. If the horse or pony does enter in the competition arena not wearing correct identification numbers, -0.50% per judge is deducted.
- **7.3.** When presenting to the judge before a test, riders do not have to stop and report to the judge but must make sure the judge has clearly seen their Horse Identification Number.

8.0 Headgear and helmets (as per EA Rule 5.2)

- 8.1 In relation to helmets and other headwear:
 - a) Any person mounted on a horse must wear an approved safety helmet with the retaining harness secured and fastened. Failure to have the harness fastened will entail elimination.
 - b) Protective headgear must conform with one of the current approved safety standards outlined below. The EA General Regulations Article 122.2 prescribes the current standards.
 - c) It is the responsibility of the rider to ensure they are using a current standard safety helmet.

8.2 Current helmet standards:

- a) Current Australian standard AS/NZS 3838 (2006 onwards) provided they are SAI Global marked
- b) New Australian standard ARB HS 2012 provided they are SAI Global marked.
- c) Current American standards ASTM F1163 (2004a or 04a onwards) provided they are SEI marked, or SNELL E2001.
- d) Current British standard PAS 015 (1998 or 2011) provided they are BSI Kitemarked.
- e) European Standard VG1 (01.040: 2014-12) with or without BSI Kitemark.

9.0 Saddlery & Equipment

As per Section 5 of the EA National Dressage Rules 2023:

- 9.1. Whips are not allowed at EA FEI-level competitions at State Championships.
- 9.2. For EA levels, the whip must not exceed 1.2 m in its entirety (Rule 5.6) for horses and not exceed 1.0 m for ponies.

10.0 Withdrawals and Refunds

- **10.1.** Entry fees will be refunded in full for withdrawals before the closing date for entries.
- **10.2.** Scratchings must be notified by 5.00 pm the day prior to the event.
- **10.3.** Refunds will not be paid unless an application is made in writing and received by the Event Secretary not more than 24 hours post event.
- **10.4.** A refund may only be made if documented proof (i.e., veterinary or medical certificate) is produced within 24 hours of the completion of the event to the Event Secretary
- **10.5.** The \$25 Administration Fee is non-refundable after the close of entries.

11.0 Objections and Complaints

(As per GENERAL REGULATIONS ARTICLE 163 and 165)

All complaints, to be valid, must be made in writing and accompanied by a deposit of A\$150.

12.0 Cancellation of the Event

- **12.1.** ETas or the OC may, at their sole discretion, cancel the event due to catastrophic conditions, disease, force majeure, or for any other reason.
- **12.2.** If the event is cancelled after it has commenced, refunds shall not be made.
- 12.3. If the event is cancelled prior to commencement, each entrant may be entitled to a partial refund of the entry fees paid. Any such refund will be determined at the absolute discretion of DTas, having regard to the direct or fixed costs for the event.
- **12.4.** Entrants who have provided an email address and/or mobile phone number will be notified of event cancellation by email and/or text message.
- **12.5.** The refund policy for withdrawal, scratching or change of an entry is set out in the Conditions of Entry.

13.0 Medication Control

Medication Control will be carried out in accordance with the EA/FEI Equine Anti-Doping & Controlled Medication Regulations 2023, 3rd Edition, effective 01 January 2023, the EA National Medication Control System and Swabbing Policy and FEI Veterinary Regulations, 14th Edition, 2018. Refer to

Please Note: The person responsible should have their horse's EA Registration licence available for identification purposes at the Event.

14.0 Entries

- **14.1.** Each entry is to be made via Nominate. Go to: www.nominate.com.au/equestdn/Nominate.aspx
- **14.2.** Closing Date: Entries close at midnight on 22 January 2024. **LATE ENTRIES WILL NOT BE ACCEPTED.**
- **14.3.** Competitions will be limited to 35 (thirty-five) horses per division. If more than 35 entries are received for a class, then a reserve list will be implemented based on percentage ranking.
- **14.4.** The onus is on competitors to confirm/check their start times the day before and on the day of the competition.
- **14.5.** Grading will be taken at close of entries.
- **14.6.** Entry of horses is limited to 2 consecutive levels, e.g., Nov/Elem, Elem/Med, Prix St Georges/Inter I, Inter II/ Grand Prix, etc., except for the Young Horse Classes.
- **14.7.** Horses may only compete in 2 classes per horse per day up to and including FEI levels (EA Dressage Rule 4.8.1.c)
- **14.8.** Horses will not be permitted to compete Hors Concours (non-competitive).
- **14.9.** No tests may be called at State Championships (EA Dressage Rule 10.3) except for Young Horse.

15.0 Fees and Charges

14.1. Class entry fees will be as follows:

Competitor (Official) \$50 DTas Member \$60 non-DTas Member

Participant (Unofficial) \$40 DTas Member \$50 non-DTas Member

- **14.2.** Freestyles will require a \$40 bond in addition to the entry fee. This will be returned in full on completion of the test.
- **14.3.** An administration fee of \$25 per rider will be charged. This fee is non-refundable after the close of entries.
- **14.4.** A TEC Ground User Fee of \$10 per rider per day will be charged.
- **14.5.** A \$15 swabbing fee per horse will be charged.

16.0 General Information

16.1 Gear check (as per EA Rule 4.4)

- a) a gear check is compulsory for each test and failure to have a gear check will entail elimination.
- b) all competitors must present to the Steward or gear checker.
- c) unless otherwise specified in the schedule or on the notice board the gear check for each test will take place prior to each test.
- d) however, in circumstances where a horse is unsettled then the combination may request to have a gear check after their test refer also to rule 6.4.1e, 6.4.1f
- e) failure to have a gear check will incur elimination.
- f) the bit inspection should not be checked until after the test unless requested by the competitor.

16.2 DOGS ARE NOT PERMITTED AT THE GROUNDS OF THE STATE DRESSAGE CHAMPIONSHIPS UNDER ANY CIRCUMSTANCES.

- **16.3** Each horse entered must have the same rider as nominated on the entry form for all competitions.
- **16.4** No horse may be ridden in competition by more than one rider.
- As per EA Rule 4.2.a) any change of rider must be notified, in writing, to the OC no later than 40 minutes prior to the start of the competition. The change must be for a legitimate reason and is at the discretion of the OC. However, a rider of a horse may not be changed if another rider has ridden the horse on the day, either in warm-up or in a competition.
- **16.6** After the close of entries, a competitor may only substitute a horse with the approval of the OC and no later than 48 hours before the start of an event (EA National Dressage Rule 4.2.b).
- 16.7 Please refer to change in rule 3.12 d): from twenty-four hours prior to the event starting, a horse may only be ridden by its nominated rider on the competition grounds. However, a groom wearing approved footwear and approved safety helmet with chinstrap done up may walk the horse on a long rein only.

17.0 Age of Riders

As per EA Rule 8.4.4.1, Young Riders may enter Competitor (Official) Competition from the start of the calendar year in which they turn 10 when riding horses, or 8 years of age when riding ponies, and must be no older than 21 years of age at midnight on 31 December 2023.

18.0 Freestyle Competitions

- **Freestyle classes will be offered at the 2024 Tasmanian State Dressage Championships, but due to the requirement for horses to compete in a maximum of two tests per day (Rule 4.8.1) will be run on the day that suits the majority of entrants. This will be known five (5) days following the close of entries. Where rule 4.8.1 prevents an entrant from competing once the schedule is known, the rider will be contacted and the class entry fee will be refunded.
- 18.2 Freestyle classes do not attract grading points.
- 18.3 Freestyle entries require the payment of a \$40 bond per rider. This bond will be refunded in full on the provision that the test is ridden, or in accordance to item 10 Withdrawals and refunds.
- 18.4 Freestyle music to be provided to the Day Coordinator no later than 9 am on the day of

competition.

- 18.5 Freestyle music must be provided in the required format, which will be advised in the official program, and is checked before the day of competition.
- 18.6 Freestyle sound check will also be available at a nominated time on Friday; to be advised in the official program.

19.0 Young Horse/Pony Classes

- **Young Horse classes will be offered at the 2024 Tasmanian State Dressage Championships, but due to the requirement for horses to compete in a maximum of two tests per day (Rule 4.8.1) will be run on the day that suits the majority of entrants. This will be known five (5) days following the close of entries. Where rule 4.8.1 prevents an entrant from competing once the schedule is known, the class entry fee will be refunded.
- 19.2 Young Horse/Pony classes do not attract grading points.
- 19.3 Birth dates for all horses/ponies will be as at 1 August 2023. Birthdate MUST be indicated on the entry form for horses entering Young Horse Classes and will be verified against EA records.
- 19.4 Please note: Young Horse classes are not State Championship YH events the tests used will be those used for qualifying events. For more Information: http://www.equestrian.org.au/dressage-YH

20.0 EA Para-Equestrian Competitors

Dressage Tasmania is proud to host a fully integrated competition with both Para-Equestrian and ablebodied athletes.

- 20.1 Para-Equestrian riders must be registered on the National PE Master List with their relevant classification.
- 20.2 Para-Equestrian riders must compete in their classified grade; they may also compete against their able-bodied peers in the Competitor/Official open classes, subject to conditions of entry in 14.0 above.
- 20.3 All riders competing in EA Para-Equestrian Dressage Tests must be classified.
- 20.4 A copy of the rider's EA PE Master List and/or EA exemption card must be provided to the Chief Steward, Gear Steward and all Judges.
- 20.5 Para Dressage athletes who have been issued with an exemption certificate must provide a copy of their FEI PE Master List to the Organising Committee with the entry form in accordance with Rule 5.18

21.0 Interschools Divisions

- 21.1 This competition is not the State Interschool Dressage Championship, but Interschools placings will be awarded across all tests.
- 21.2 Riders must hold an Interschools License to be eligible for Interschools placings.
- 21.3 All Dressage tests will be run in accordance with current EA Dressage Rules (1/7/2023), which can be obtained from http://www.equestrian.org.au/dressage-rules.
- 21.4 Riders are permitted to enter two consecutive levels per horse and must not compete in more

than two tests per day.

- 21.5 Whips are permitted (not exceeding 1.2m including tassel for horses and 1.0m for ponies)
- 21.6 Tests cannot be called.

22.0 Young Rider Divisions

Placings for young riders will be awarded in all Competitor/Official classes.

23.0 Arena Familiarisation

Arena & ground familiarisation will be offered from Friday. Times to be advised in the official program.

24.0 Lunging

Is available in assigned areas only.

25.0 Catering

Food and refreshments will be available for purchase on both days. A coffee van will also be on site. This may vary according to COVID19 restrictions in place at the time of the event. Updates will be provided on the Facebook page.

26.0 Horse Agistment

Please watch the 2024 Tasmanian Dressage Championships Facebook page for agistment opportunities.

27.0 Camping

Camping is available at TEC at a charge of \$11 a night (non-powered site) or \$15 a night (powered site) per person per night and can be booked at time of entry. Yards are available for \$10 per night.

SIR ARCHIBALD TROPHY

Donated by Lyn Bourn in recognition of Meegan Daun's Tasmanian bred, owned and trained horse who went from young horse to Grand Prix. Awarded to the highest scoring combination in young horse classes.

MASTERS PERPETUAL TROPHY

The Masters Trophy is awarded to the rider 60 years of age or over who achieves the highest aggregate percentage of the two best official tests ridden over the weekend.

RAY WEBSTER PERPETUAL Award

In memory of Ray Webster. This trophy is awarded to the best-performed Tasmanian Young Rider based on the highest average percentage of two official tests ridden.

DUTCHBOY HIGH PERFORMANCE YOUNG RIDER PERPETUAL TROPHY

This trophy is awarded to the Young Rider scoring the highest percentage in an FEI test.

GENTLEMAN RIDER PERPETUAL TROPHY

Perpetual trophy donated by the Southern Zone Committee at the 2021 Championships. This trophy is awarded to the male rider scoring the highest percentage of the Championships (NOT including freestyle tests).

TONNERRE PERPETUAL TROPHY

Donated by Barb Rowsell in memory of her Grand Prix champion gelding Tonnerre. This trophy is donated to the winner of the highest FEI level test contested at the Championships.

SORELL REGIONAL SHOPPING CENTRE PERPETUAL AWARD

Donated by Luiz C. Menezes in the memory of his Andalusian stallion Casa Real. The trophy is awarded to the best performed warmblood based on the highest average percentage of two official tests.

TASRACING OFF THE TRACK AWARD

Reserve Champion to be presented with sash. Winners are to be available for a promotional interview with Tasracing.

SCRUPLES LODGE THOROUGHBRED RACING STABLES PERPETUAL TROPHY

This trophy is awarded to the thoroughbred horse gaining the highest average highest average percentage of two official tests. Horses must be registered with the Australian Register of Racehorses.

BEST PERFORMED STANDARDBRED PERPETUAL TROPHY

Donated in 2021 to encourage Standardbreds to participate in dressage. This trophy is awarded to the standardbred horse gaining the highest average percentage of all tests ridden over the Championships (minimum two tests).
