It is up to Competitors to be familiar with the EA Rules for Dressage.

Top Hats – May be worn by Athletes who are 22 years and older and who are riding Horses that are seven (7) years and older may wear a top hat instead of Protective Headgear. However, this exception is limited to **the actual Competition and the warming-up directly prior** to the Competition (with no break before the Competition), which includes riding between the stable and the warm-up area, riding of the competing Horse in the warm-up area, and riding back to the stable. The **gear stewards** will be asked to come to the arena for gear checking purposes.

Bridle Numbers – Must be worn on BOTH sides of either bridle or saddle blanket

Arena Familiarization – Horses may be led or ridden (walk or trot only) around the arenas until 8:45. **The areas around the arenas** is considered the 'Competition Area' and riders are only to ride there when ready to present to the Judge before their test, apart from the stated time for Arena Familiarization.

Lunging – In the fenced 'Pony Club' area or the round yard.

Yards – Please leave the yards clean if you use them.

Dogs – **NO** dogs allowed at TEC.

Children – Children under 10 to be under adult supervision at all times for their safety and as a courtesy to competitors. Horses are unpredictable and DT accepts no responsibility for any accident or injury.

Foot Traffic – For safety reasons please stick to spectator areas as shown on map.

Canteen – Canteen will be run by Jill Schwartz and the Young Rider Squad Parents.

Volunteers – Many volunteers are needed to run each competition. If you can help in any way please contact the Volunteer Coordinator or Day Coordinator.



The Australian Sports Anti-Doping Authority (ASADA) is Australia's driving force for pure performance in sport and aims to protect Australia's sporting integrity through the elimination of doping. ASADA deters the use of banned doping practices in sport through education, testing, advocacy and coordination of Australia's anti-doping program. It is the organisation with prime responsibility for implementation of the World Anti-Doping Code in Australia.

Athletes are advised to check the status of their existing and new medications every year due to possible changes in conditions of use.

The WADA strict liability principle states the athlete is responsible for any substances detected, regardless of how they got there.
