- Entry is \$45 for the riders first class (\$20 discount for TEA (NTEC/NWEA/STEA) members.
- \$15 for each additional class or horse for the **same rider**.
- Each horse may compete in two classes.

#### **Combined Training Competition Day**

#### Programme

• A detailed draw will be emailed to riders the week prior to the day.

#### **Dress & Presentation**

• Neat and casual dress only

#### Rules

- <u>Combined Training –</u> consists of a dressage test and showjumping round. Run under EA eventing rules
- Dressage Phase Snaffle bits only. Whips not permitted.
- Callers for the dressage test are permitted, however riders who use a caller will have extra points added to their dressage score. If entries permit, grades will be divided into 'called' and 'uncalled'. Please indicate on your entry form.
- Dressage tests are available on the EA Tasmania website, under sports, dressage, dressage tests.

#### **Jumping Phase**

• Back protectors and medical armbands are recommended.

#### **Riders Numbers**

- Riders need to provide their own number holders for the day, either bridle, saddle blanket or riders back number holders are acceptable.
- Numbers for the back holders will be provided at the NTEC caravan. Back number holders will also be available for purchase at the caravan.

#### Canteen

• No canteen available

#### **Riders Event Assistance**

Riders are asked to arrive promptly to set up the arenas at the beginning of the day.
Where possible riders are asked to either provide a helper for pencilling or marshalling on the day.
