# Show Information

## GENERAL INFORMATION:

- **FUNDRAISING:** The concept of this show is to raise funds to assist our Tasmanian Show Horse Team. Winners and Runner Ups from the Tasmanian EA Horse of the Year in January (with third placegetters on standby) are all eligible to compete at the National Show Horse Championships in Werribee in December and all funds raised from this show will go towards the cost of competing.
- **SAFETY:** Helmets are to be worn at all times whilst riding and must be safety approved. Safe riding boots are to be worn by riders, and safe, closed toed shoes worn by handlers.
- **JUDGES:** Please remember that judges must not be approached by riders, handlers or onlookers – all enquiries are to be directed through the ring steward.
- **RIBBONS:** Our ribbons are pre-loved, and have been kindly donated.
- **RULES:** This event is being run under Equestrian Australia rules. Please refer to their website for further information. [www.equestrian.org.au/showhorse](http://www.equestrian.org.au/showhorse)

## CLASS DEFINITIONS & GLOSSARY

- **OFFICIAL CLASSES:** Exhibits must be registered with EA, and riders must be current financial members
- **UNOFFICIAL CLASSES:** Unofficial classes are open to all combinations
- **NOVICE:** Not to have won an open hacking class or 3 novice classes at a Show, Gymkhana or Funday.
- **INTERMEDIATE:** For exhibits who have not won an open height or weight class at Royal/National Show or Top 5 at a Horse of the Year.
- **BEST PRESENTED:** Best overall presentation of horse and rider combinations.
- **WEIGHT CLASSES:** Split into light and heavy. If unsure, competitors are welcome to ask the steward for the judge's recommendation.
- **CHAMPION:** All 1<sup>st</sup> place winners for each class in their section are eligible for the championship.
- **RESERVE CHAMPION:** Once the Champion is sashed, any horse & rider combination who placed second to the Champion horse/rider will be invited to compete for Reserve Champion (if not already in the Championship as a class winner).
- **SUPREME:** All Champions from each relevant section will be invited to compete in the Supreme.
- **RIDING CLASSES:** Open to both Official and Unofficial Riders- Age is at day of Show
- **TOPSY RIDERS:** Can be on or off the lead, horses can be any height, and riders any age
- **INTERSCHOOLS:** Competitors to be wearing school uniform, scoring as set out below.
